**“DOMINUS FLEVIT” PILGRIMAGE TO ISRAEL**

A. PRICE AND PAYMENT SCHEDULE, LEGAL DETAILS, ETC.

1) PRICE, ETC.:

PRICES: All prices on this price schedule reflect a cash discount for payment by check, money transfer, or cash. If payment is by credit card price is approximately 3% higher.

PRICE: The trip price of \$4300 (double occupancy) reflects a \$135 cash discount if all payments except the initial \$200 deposit are made by check, money transfer, or cash. Land-only price is \$1000 less. Single supplement is \$900 additional, if available. (If payment is by credit card, trip price is \$4435 ppdo, single supplement \$930.)

Price includes round-trip airfare from New York City’s JFK airport (JFK) to Israel, departing Wednesday May 8, 2023 and returning Saturday May 18. Airline and particular New York area airport subject to change until 90 days before departure.

TOUR PRICE includes:

- R/T air travel from New York area airport, including all taxes and “fuel surcharge” fees
- 9 Nights lodging (double occupancy) with private bath. All our accommodations are in religious pilgrimage houses (Nazareth, Sea of Galilee, and the Old City in Jerusalem)
- Breakfast and Dinner each day in Israel.
- Private Motor Coach (A/C, Wi-Fi, etc.), guides, entrance fees, etc.
- Accompaniment of a Catholic Priest
- Note: if comparing with other Holy Land pilgrimages, please note that this trip price includes all airline taxes or fuel surcharges (typically not included, and can be over \$900 additional). Also our group will be limited to a maximum of 26 pilgrims.

PRICE DOES NOT INCLUDE:

- Domestic Airfare to/from New York area airport or overnight accommodations there if needed.
- Lunches. Usually average about \$20/day. Please about \$200 cash to cover lunches.
- Beverages with meals unless specified.
- Other personal expenses.
- Tips for bus driver and our licensed guide. Each pilgrim should bring \$90 in cash for the tips.
- Items not specifically mentioned as included in pilgrimage flyer.

CHECKED BAGGAGE: Tour price includes one checked bag and one carry-on, both subject to airline weight and size restrictions. Porter service is often not available at the religious houses where we stay, so please bring only one checked bag on this trip.

## 2) RELEASE:

Dominus Flevit and Roy Schoeman do not own or operate any entity which is to or does provide goods or services for your trip, and hence are not responsible for any negligent or willful act or failure to act of any person or entity they do not own or control. Without limitations, they are not liable for any direct, indirect, consequential, or incidental damage, injury, death, loss, accident, delay, inconvenience or irregularity of any kind which may be occasioned by reason of any act or omission beyond their control, including, without limitation any willful or negligent act, failure to act, breach of contract or violation of local law or regulation of any third party such as an airline, train, hotel, bus, taxi, van, local ground handler or guide. Similarly, Dominus Flevit and Roy Schoeman are not responsible for any loss, injury, death or inconvenience due to delay or changes in schedule, overbooking of accommodation, default of any third party, attacks or bites by animals, insects or pests, injury or death while on activities sponsored by lodging facilities or by other third parties, sickness, the lack of appropriate medical care, evacuation to same, if necessary, weather, strikes, acts of God or government, acts of terrorism, or the threat thereof, force majeure, war, quarantine, epidemics, or the threat thereof, criminal activity, or any other cause beyond its control. Should Roy or the accompanying Priest be unable to participate in this tour, reasonable effort will be made to secure substitute(s). Regardless of their participation, the tour will proceed as scheduled on the dates listed. Dominus Flevit and Roy Schoeman are not responsible for any loss incurred by traveler, including lost days of the scheduled tour, due to a cancelled flight or other means and modes of transportation.

## 3) TRAVEL PROTECTION

Travel protection policies are available from a number of independent insurers, and vary in what they cover, the amount of coverage, the conditions necessary for coverage, cost, etc. We do not provide such travel protection, but we do recommend it for protection against unforeseen circumstances. One good resource is [Squaremouth.com](http://Squaremouth.com), a site which lists and compares prices, terms, and reviews of insurance companies that provide such travel protection.

## 4) TRAVEL ADVISORIES AND WARNINGS

From time to time the State Department of the United States, the Center for Disease Control, and other government agencies and departments issue travel advisories or warnings for one or more of the destinations that may be included on tour. We encourage you to contact these agencies directly to obtain the most current information. Dominus Flevit cannot change the cancellation terms and conditions based on the issuance of any such warning or advisory or the occurrence of any act of terror, health, or other incident, in one or more of the places this tour is scheduled to visit. All cancellation fees remain in full force and effect.

## 5) RESTRICTIONS

Pilgrims should be prepared for several miles of walking a day. Not all sites, nor accommodations, are handicap accessible. Registrants must be over 21 years old.

## 6) TRIP CANCELLATION BY DOMINUS FLEVIT

Dominus Flevit may cancel a tour by reason of any event or occurrence which it deems to create a concern for travel safety, or if any major component of a tour (i.e., transportation or accommodation) shall be canceled as a result of such event. These events can include, but are not limited to, war, threat of war, civil strife, terrorist activity and its consequences or the threat of such activity, riot, the act of any government or other national or local authority, industrial dispute, natural or nuclear disaster, fire, chemical or biological disaster and adverse weather, and all similar events outside of Dominus Flevit's or the supplier(s) control. In such event, Dominus Flevit's sole liability to the traveler shall be to refund such amount that Dominus Flevit receives as a refund from its vendors.

## 7) LAND ONLY OPTION

The land only option, if available, is \$3300 with the cash discount (\$3420 without it). Please inquire whether it is available prior to registration. Anyone flying on their own is responsible for meeting up with the group in Israel, either at the airport on the group's arrival, or at the group's first night lodging. Availability of the land-only option is dependent on the group meeting the airline's minimum number of travelers to qualify for the group airfare.

## 7) PURCHASING CONNECTING FLIGHT OR LAND ONLY AIRFARES

Please do not purchase any non-refundable connecting flight or land only airfares until 60 days prior to the trip, since details of the group flight may change.

## 8) INTERNATIONAL FUNDS TRANSFERS

All payments must be made in US dollars. Any bank transfer, wire transfer, etc. fees are to be paid by the traveler. Checks must be drawn on US banks.

## 9) PAYMENT TERMS & SCHEDULE:

Payment Details:

- Checks (drawn on US banks only, please) should be made out to **"Dominus Flevit"** and mailed to Roy Schoeman, 4730 Navassa Lane, Naples, FL 34119. If sent after April 15, 2024 please contact Roy for the proper mailing address. Checks and ACH bank transfers receive the "cash" discount.
- Money transfers must be made by ACH bank transfer. Any money transfer or currency conversion fees are paid by the payer.
- Contact Roy for money transfer or credit card payment details. The cash discounts do not apply if any payment other than the initial \$200 deposit is made by credit card.
- I do not accept payments by Venmo, PayPal, or similar (too unreliable and without recourse).

Payment Schedule:

- Fill out and send in the information form and details.
- DO NOT send in deposit until informed of availability.
- Once informed of availability, \$200 deposit per person is due to register.
- \$1500 additional payment per person due by Dec. 15, 2023
- Balance is due by March 15, 2024
- The refund policy in the case of cancellation is as follows:
  - Initial \$200 deposit is fully refundable for 20 (twenty) days after registration, non-refundable thereafter.
  - Cancellations prior to January 15, payments refunded less \$1000.
  - Cancellations prior to February 15, payments refunded less \$1500
  - Cancellations prior to April 1, payments refunded less \$2500
  - No refund for cancellations after April 1

In order to protect against unforeseen circumstances requiring cancellation, travel insurance is strongly recommended.

10) BINDING ARBITRATION:

I agree that any dispute concerning, relating or referring to this Agreement, the brochure or any other literature concerning my trip, or the trip itself, shall be resolved exclusively by binding arbitration pursuant to the Federal Arbitration Act, 9 U.S.C. §§1-16, either according to the then existing Commercial Rules of the American Arbitration Association (AAA) or pursuant to the Comprehensive Arbitration Rules & Procedures of the Judicial Arbitration and Mediation Services, Inc. (JAMS). Such proceedings will be governed by substantive (but not procedural) Florida law and will take place in Naples, FL. The arbitrator and not any federal, state, or local court or agency shall have exclusive authority to resolve any dispute relating to the interpretation, applicability, enforceability, conscionability, or formation of this contract, including but not limited to any claim that all or any part of this contract is void or voidable. Please understand that by agreeing to these terms and conditions, you (and we) are waiving our right to a trial.
